

MARRIAGE LICENSE BUREAU THE CITY OF NEW YORK OFFICE OF THE CITY CLERK

APPLICATION FOR ONE-DAY MARRIAGE OFFICIANT LICENSE

(PRINT CLEARLY IN BLACK INK)

- A One-Day Marriage Officiant shall be eighteen years of age or over and need not be a resident of the town or city to which they apply
 or a resident of New York State. A One-Day Marriage Officiant shall have the authority to solemnize a marriage anywhere in New
 York State.
- An applicant for a One-Day Marriage Officiant License must apply for such license in the same town or city clerk's office as the couple to be married. (For NYC Manhattan Office only)
- The fee for a One-Day Marriage Officiant License is \$25.00.
- A One-Day Marriage Officiant License shall only be valid for the parties to be married as stated on the application and shall expire upon the earlier of either completion of such solemnization or the expiration of the marriage license.

 One-day marriage officiants shall be exempt from registration as required pursuant to Section 11-b of the Domestic Relations Law.
