Important Information Regarding Notice of Intent to Participate in the Amnesty Program

Pursuant to paragraph one of subdivision (i) of section 3-223 of the Administrative Code of the City of New York (“Administrative Code”), the Office of the City Clerk (“City Clerk”) is establishing an Amnesty Program for: (1) any lobbyist who was required to file, but has never filed, a statement of registration pursuant to section 3-213 of the Administrative Code, at any time on or after December 10, 2006 and (2) any client who was required to file, but has never filed, an annual report pursuant to section 3-217 of the Administrative Code, at any time on or after December 10, 2006.

Any such lobbyist or client may participate in a pre-amnesty by filing the attached Notice of Intent to Participate in the Amnesty Program (“Notice of Intent”) before the effective date of the amnesty program. By filing this Notice of Intent, a lobbyist or client indicates the intention to participate in the Amnesty Program and to comply with the Lobbying Law as of the date of the filing. In order to qualify for amnesty, the applicant, in addition to filing the Notice of Intent, must file the application during the term of the Amnesty Program and comply with the Lobbying Law.

being duly sworn state the following under the penalties of perjury.

1. During the period December 10, 2006 to the present, the Entity was required to file
(check as applicable):

() a statement of registration with the Office of the City Clerk (the "City Clerk")
pursuant to section 3-213 of the Administrative Code of the City of New York (the
"Administrative Code") and/or

() a client annual report with the City Clerk pursuant to section 3-217 of the
Administrative Code.

2. The Entity has not filed a statement of registration or client annual report with the City
Clerk from _____ (must be a date on or after December 10, 2006) to the date of this
application.

3. The Entity is neither the subject of any criminal investigation relating to any violation of the Lobbying Law nor a party to any criminal litigation in any court of New York or of the United States relating to any violation of the Lobbying Law.

4. The Entity is filing this Notice of Intent to Participate (the “Notice of Intent”) as proof of its intent to participate in the amnesty program in accordance with paragraph two of subdivision (i) of section 3-223 of the Administrative Code.

5. Upon filing this Notice of Intent, the Entity will immediately comply with the Lobbying Law by: enrolling in e-Lobbyist and filing all required reports including, but not limited to, statements of registration, periodic reports or a client annual report and submitting an application for amnesty during the eligibility period.

6. I understand that the City Clerk will act in reliance on the statements made in this Notice of Intent and any action taken in reliance on these statements may be nullified if such statements are false or misleading.

7. I understand that in order to qualify for the Amnesty Program, in addition to filing this Notice of Intent, I must file for amnesty during the applicable period.

8. I understand that **only** upon compliance with all applicable provisions of section 3-223 (i)(3) of the Administrative Code will the City Clerk waive any late filing penalties and civil penalties.

9. I understand that if my application for amnesty pursuant to paragraph three of subdivision (i) of section 3-223 is denied, I may be liable for any late filing penalties and civil penalties that could be assessed against me for any period beginning on or after December 10, 2006.
