ORDER WAIVING  
TIME REQUIREMENT

for an Order Authorizing the Immediate Solemnization  
of Their Proposed Marriage, Pursuant to § 13-b of  
the Domestic Relations Law

Upon reading the annexed petition of \_\_\_\_\_ and  
\_\_\_\_\_, verified the 24<sup>th</sup> day of July, 2011,

And it appearing to the satisfaction of this Court from an examination of said  
license and the proofs submitted by said parties that a delay of said marriage will work  
a great hardship upon the contracting parties or upon one of them, and that no previous  
application for the relief herein prayed for has been made to this court or any other  
judge thereof or any other court or judge thereof;

Now, therefore, pursuant to the provisions of § 13-b of the Domestic Relations  
Law, it is

ORDERED, that the immediate solemnization of the proposed marriage between  
the petitions be, and the same hereby is authorized, and the provisions contained in the  
said statute for the lapse of the twenty-four hour from the date and hour of issuance of  
the marriage license for such marriage be and the same is dispensed with; and it is  
further

ORDERED that any person authorized by law to perform marriages within the State of New York, to whom this order and said license may come, is hereby authorized and empowered immediately to solemnize the rites of matrimony between the above-named petitioners, and it is further

ORDERED that within five days of the solemnization of the said marriage, the person solemnizing such marriage, file this Order, together with the accompanying affidavit and the said license, with the Clerk of the City of New York.
