

Introduction

Lobbying in the City of New York is governed by Administrative Code §§ 3-211 through 3-223 and Chapter 1 of Title 51 of the Rules of the City of New York (collectively, the "Lobbying Law.") This is the sixteenth annual report issued by the Lobbying Bureau (the "Lobbying Bureau") of the Office of the City Clerk (the "City Clerk") pursuant to § 3-212(c) of the Administrative Code of the City of New York (the "Administrative Code"), the text of which follows:

The city clerk shall prepare and post on the internet an annual report relating to the administration and enforcement of the provisions of this subchapter. Such report shall contain information regarding (i) the number of complaints received from the public and the disposition of such complaints; (ii) the number and amount of civil penalties imposed pursuant to subdivisions (a), (b), (c) and (d) of section 3-223 of this subchapter; (iii) the number and duration of orders issued pursuant to subdivision (a) of section 3-223 of this subchapter; (iv) the number of random audits conducted by the city clerk and outcomes thereof; (v) compliance programs developed and implemented for lobbyists and clients; (vi) the types and number of requests for assistance related to the lobbying law received by the city clerk, and, as soon as practicable, the average response and resolution times of such requests; (vii) the number of lobbyists filing statements of registration pursuant to section 3-213 of this subchapter for the first time; (viii) the subject matter of lobbying activity most frequently reported by lobbyists; (ix) the lobbying targets most frequently reported by lobbyists; (x) the lobbyists that received the highest compensation; and (xi) such other information and analysis as the city clerk deems appropriate. Such report shall be posted on the internet no later than March first of each year and shall contain information relating to the preceding calendar year.

Listed hereafter is the information required by the Administrative Code for calendar year 2021.

(i) Number of complaints received from the public and the disposition of such complaints.

In 2021, the Lobbying Bureau did not receive any complaints from the public regarding possible violations of the Administrative Code.

There was 1 open investigation based on a complaint received in 2019. It alleged that East Village Community Coalition, Inc., George Arzt Communication, Inc., HR&A Advisors, Inc., Denham, Wolf Real Estate Services, Inc., La Vida Feliz Foundation, The Greenwich Village Society for Historic Preservation, Inc. and Dentons US LLP violated Administrative Code §§ 3-213(a)(1); 3-216(a)(1) or 3-217(a) *et seq*. After review of the complaint and a subsequent investigation, the City Clerk found no probable cause that the above-listed entities violated the Administrative Code and closed the investigation in 2021.

(ii) Number and amount of civil penalties imposed pursuant to subdivisions (a), (b), (c) and (d) of § 3-223 of the Administrative Code.

Violators of the Lobbying Law are subject to the penalties detailed in Administrative Code § 3-223 *et seq*. Pursuant to Administrative Code § 3-223(a), the penalties for knowing and willful violations of the Lobbying Law include: a civil penalty not to exceed \$30,000; the issuance of a cease and desist order; or both a civil penalty and a cease and desist order. Pursuant to Administrative Code § 3-223(b), violators are subject to a civil penalty not to exceed \$30,000 for violating a cease and desist order or for violating the proscription against contingency agreements. In addition to penalties for any late filing, pursuant to Administrative Code § 3-223(c), violators may be subject to a civil penalty, not to exceed \$20,000, if a violation is not cured. Lastly, for any violation of the Lobbying Law not covered in the foregoing provisions, pursuant to Administrative Code § 3-223(d), violators may be subject to a civil penalty not to exceed \$20,000, if a violation is not cured.

Listed below are the late filing and civil penalties¹ incurred for each reporting period as of February 25, 2022.

¹ The late filing penalties contained in this report are restricted to penalties resulting from the late filing of 2020 annual reports (client annual reports, sixth periodic reports and sixth periodic fundraising and political consulting reports) and 2021 filings including: statements of registration, first through fifth periodic reports, and first through fifth periodic fundraising and political consulting reports.

2020 Reports (Client Annual Reports, Sixth Periodic Reports and Sixth Periodic Fundraising and Political Consulting Reports)

The Lobbying Bureau identified 38 Lobbyists² that failed to timely file an aggregate of 60 sixth periodic/annual reports³ for 2020. For this failure, such Lobbyists incurred \$6,675.00 in aggregate late filing penalties. (See <u>Appendix A</u> attached hereto.)

The Lobbying Bureau identified one Lobbyist who failed to timely file a sixth periodic fundraising and political consulting report. For this failure, such Lobbyist incurred \$125.00 in aggregate late filing penalties. (See <u>Appendix B</u> attached hereto.)

The Lobbying Bureau identified 273 late client annual reports. For this failure, such clients incurred \$75,847.50 in aggregate late filing penalties. (See <u>Appendix C</u> attached hereto.)

No civil penalties were warranted for the late filing of the above-listed reports.

2021 Statements of Registration and Periodic Reports

The Lobbying Bureau identified 62 Lobbyists who failed to timely file an aggregate of 151 statements of registration. For this failure, such Lobbyists incurred \$57,187.50 in aggregate late filing penalties. (See <u>Appendix D</u> attached hereto.) No civil penalties were warranted in connection with such failures.

One hundred and sixty-four Notices to Cure were sent to Lobbyists who failed to timely pay registration fees or submit retainer agreements or amended retainer agreements. The Lobbyists cured such failures either by paying the fees or submitting the retainers. No civil penalties were warranted in connection with such failures.

The Lobbying Bureau identified 35 Lobbyists who failed to timely file an aggregate of 56 first periodic reports. For this failure, such Lobbyists incurred \$5,825.00 in aggregate late filing penalties. (See Appendix E attached hereto.)

The Lobbying Bureau identified 26 Lobbyists who failed to timely file an aggregate of 43 second periodic reports. For this failure, such Lobbyists incurred \$5,250.00 in aggregate late filing penalties. (See <u>Appendix F</u> attached hereto.)

² As used throughout this report, "Lobbyists" refers to lobbying firms as well as lobbyist/client filers.

³ The Lobbying Bureau has historically treated the sixth periodic report as equivalent to an annual report for lobbyists.

The Lobbying Bureau identified 33 Lobbyists who failed to timely file an aggregate of 80 third periodic reports. For this failure, such Lobbyists incurred \$3,325.00 in aggregate late filing penalties. (See <u>Appendix G</u> attached hereto.)

The Lobbying Bureau identified 34 Lobbyists who failed to timely file an aggregate of 41 fourth periodic reports. For this failure, such Lobbyists incurred \$7,685.00 in aggregate late filing penalties. (See <u>Appendix H</u> attached hereto.)

The Lobbying Bureau identified 23 Lobbyists who failed to timely file an aggregate of 26 fifth periodic reports. For this failure, such Lobbyists incurred \$4,900.00 in aggregate late filing penalties. (See <u>Appendix I</u> attached hereto.)

2021 Fundraising and Political Consulting Reports

The Lobbying Bureau identified 2 Lobbyists who failed to timely file a total of 2 fundraising and political consulting reports. For this failure, such Lobbyists incurred \$575.00 in aggregate late filing penalties. (See Appendix J attached hereto.)

No civil penalties were warranted for the late filing of fundraising and political consulting reports.

2021 Termination Notices

One hundred and six Notices to Cure were sent to Lobbyists and 339 Notices to Cure were sent to clients who failed to timely file termination notices. The filers cured such failures either by filing the missing termination notice or extending the lobbying contract. One client failed to timely cure. Enforcement proceedings for this client are pending.

(iii) Number and duration of orders issued pursuant to subdivision (a) of § 3-223 of the Administrative Code.

None.

(iv) Number of random audits conducted by the city clerk and outcomes thereof.

The Lobbying Bureau selected 45 Lobbyists for audit in 2021. The 2021 audits encompass an examination of all filings made in 2020 by the 45 randomly selected Lobbyists and associated clients, to determine if such filings were complete, accurate, timely filed and otherwise in compliance with the Lobbying Law. The audits normally result in the issuance of findings and required actions. Examples of previous audit findings include: reporting incorrect compensation and expenses; failing to report reimbursed expenses; failing to file termination notices; failing to properly describe subject details; failing to file correct targets; inadvertently listing the names of children of lobbying employees in the statement of registration; and inadvertently removing the names of lobbying employees from the statement of registration. Examples of previous required actions include: correcting compensation and expense amounts; reporting reimbursed expenses; filing termination notices; amending reports to properly describe subject details; correcting targets; removing the names of children of lobbying employees from the statement of registration; and amending the statement of registration to relist incorrectly removed names of employees.

(v) Compliance programs developed and implemented for lobbyists and clients.

The Lobbying Bureau works with filers⁴ to improve compliance with the Lobbying Law in a variety of ways including training, outreach and other educational efforts. In addition, the Lobbying Bureau receives numerous telephone and e-mail inquiries throughout the year for: assistance with filing reports; questions regarding requirements of the Lobbying Law; and technical assistance with e-Lobbyist. See (vi) The types and number of requests for assistance related to the lobbying law received by the city clerk for further information. Responding to these questions and requests for assistance continues to be an integral part of the Lobbying Bureau's daily functions.

⁴ As used throughout this report, unless otherwise stated, "filers" refers to lobbyist entities, lobbyist/client entities and clients.

Amendment of Rules

In 2021, the Lobbying Bureau worked with the Law Department to finalize amended rules regarding the definition of lobbying applicable to architects and engineers as mandated by Administrative Code § 3-211(c)(3)(x). Specifically, the rules amend Chapter 1 of Title 51 of Rules of the City of New York by adding a subdivision defining what constitutes "minor" pursuant to Administrative Code § 3-211(c)(3)(x). Consequently, authorizations by the City Planning Commission pursuant to the zoning resolution and decisions related to real property by other boards or commissions designated as minor by the City Clerk are excluded from the reporting requirements of the Administrative Code. The amended rule was proposed and published in the City Record on November 29, 2021. The required public hearing was held on December 29, 2021. The Notice of Adoption was published in the City Record on February 25, 2022. Pursuant to the Citywide Administrative Procedure Act, the rule will be effective March 25, 2022.

Training

The Lobbying Bureau instituted a mandatory training program for Lobbyists in 2016 as required by the Lobbying Law. Lobbyists must complete the training biennially. If a Lobbyist registers 30 or more clients and lists 5 or more lobbying officers or employees, then 2 officers or employees, 1 of whom must have lobbied in the prior year, must complete the training.

In 2021, in connection with the mandatory training program, the Lobbying Bureau conducted 11 trainings with approximately 255 attendees. Three lobbyist training sessions and 8 lobbyist/client filer training sessions were held. Each session included a detailed overview of the requirements of the Lobbying Law and provided in-depth instructions on filing reports in e-Lobbyist. Sessions were held remotely via Zoom. Fifty-five filers opted to fulfill the training program via pre-recorded video.

Four Notices to Cure were served in connection with the failure of Lobbyists to attend mandatory training. All Lobbyists subsequently cured the violation by completing training within the required cure period. No civil penalties were warranted for failure to attend training.

Outreach Efforts

Notification to Recipients of Discretionary Funds under the City Council Fiscal Year 2022 Adopted Expense Budget - Schedule C

The Lobbying Bureau sent approximately 1,700 emails to entities that received discretionary funding from the City Council for fiscal year 2022 that were not registered New York City Lobbyists. Enclosed with the email was a summary of the Lobbying Law. The email alerted entities to the Lobbying Law and encouraged them to review their activities and related compensation and expenses to determine whether or not they were required to comply. The Lobbying Bureau received numerous telephone and email inquiries as a result of this outreach effort.

Comparison of New York City and New York State Lobbying Reports

The Lobbying Bureau continued its efforts to uncover unreported City lobbying in 2021 by comparing 5,328 statements of registration filed with the Joint Commission on Public Ethics ("JCOPE") with statements of registration filed with the Lobbying Bureau as of September 1, 2021.

In total, 37 entities reported lobbying City targets with JCOPE but did not file a statement of registration with the Lobbying Bureau. As a result, the Lobbying Bureau sent notices to the entities. Thirty-five entities submitted affidavits affirming that they were not required to file statements of registration because: (1) the entity inadvertently listed a New York City target on the JCOPE statement of registration when no City lobbying took place; or (2) the entity did not exceed the \$5,000 reporting threshold for City lobbying. One entity filed the required reports and paid late filing penalties. The remaining entity is facing pending litigation.

Other Compliance Efforts

The Lobbying Bureau examines reports filed on e-Lobbyist to determine the accuracy of the information contained in the statements of registration, retainer agreements and periodic reports. In 2021, the Lobbying Bureau reviewed approximately 2,569 retainer agreements filed by lobbyists to ensure that the retainer agreements complied with the Lobbying Law.

Retainer Issues

All retainer agreements must contain: (1) the compensation payable to the Lobbyist; (2) the client's name; (3) the terms of any third-party payments for the lobbyist's services; and (4) the duration of the term of representation, including the specific start date. *See* Chapter 1 of Title 51 of the Rules of the City of New York § 1-08. The Lobbying Bureau identified approximately 39 statements of registration which contained retainer issues including: (1) failure to include a full force and effect letter, (2) failure to upload the original retainer with the amended retainer, and (3) uploading the wrong retainer. Non-compliant Lobbyists were contacted and required to correct the retainer issues within the cure period. Nine Notices to Cure were served on 5 Lobbyists. The Lobbyists cured the retainer issues and no civil penalties were imposed.

Date Issues

In order to resolve date discrepancies, the Lobbying Bureau cross-checked start and end dates listed on the statements of registration with the corresponding retainer agreements contained in e-Lobbyist. The Lobbying Bureau identified approximately 129 statements of registration which contained issues with start and end dates in Lobbyists' filings by comparing the dates on the statements of registration with the dates listed on the related retainer agreements. Lobbyists were instructed to cure by amending either the date on the statement of registration or the date on the corresponding retainer agreement. Seven Notices to Cure were served on seven Lobbyists. The Lobbyists cured the date issues and no civil penalties were imposed.

Entity Name Issues

In order to resolve entity name discrepancies, the Lobbying Bureau cross-checked client names listed on the statements of registration and retainer agreements with the client enrollment name. The Lobbying Bureau identified 46 statements of registration which contained entity name issues. Notices to Cure were served on 6 Lobbyists for a total of 7 entity name issues. The Lobbyists were instructed to cure by: (1) filing an amended statement of registration with an amended retainer agreement listing the correct name; or (2) enrolling the new entity and filing reports under the new entity name. The Lobbyists cured the entity name issues and no civil penalties were imposed.

(vi) The types and number of requests for assistance related to the lobbying law received by the city clerk.

In 2021, the Lobbying Bureau recorded its activities and the types and number of requests received.⁵ From January 1, 2021 through December 31, 2021, the Lobbying Bureau's time was allocated as follows: compliance 49%, audits 28%, enforcement 10%, e-Lobbyist assistance 5%, outreach/training 5% and investigations 3% (see page 38).⁶ In addition, the Lobbying Bureau received approximately 586 telephone calls (see pages 39-41) and 4,927 email requests (see pages 42-44). The majority of telephone calls consisted of compliance inquiries. The majority of emails involved filers requesting technical assistance in completing a filing on e-Lobbyist.

(vii) The number of lobbyists filing statements of registration pursuant to § 3-213 of the Administrative Code for the first time.

In 2021, 43 Lobbyists filed statements of registration for the first time. This is a 30% increase from the previous year. Thirteen of these entities are lobbyists and thirty entities are lobbyist/client filers. The 30 lobbyist/client filers' industry categories were reported as follows: 11 banking and financial services; 5 public, community interest and not-for-profit organization; 4 technology, telecommunications and other media; 3 transportation; 2 health and mental hygiene, 2 environment and natural resources; 1 advertising, 1 arts and culture; and 1 labor.

(viii) The subject matter of lobbying activity most frequently reported by lobbyists and lobbyist/client filers.

(xi) Other information and analysis.

Number of Reporting Lobbyists and Clients

As of February 25, 2022, approximately 2,567 Lobbyists and 6,370 clients were enrolled in e-Lobbyist. In 2021, approximately 2,569 statements of registration were filed on e-Lobbyist and Lobbyists paid approximately \$184,750 in registration fees.

Outlook For 2022

In 2022, the Lobbying Bureau will remain focused on compliance and enforcement of the Lobbying Law. The Lobbying Bureau will continue to: (1) fulfill its statutory mandates; (2) confirm the veracity of reports filed by Lobbyists and clients; (3) check information contained in the reports to verify the accuracy of the filings and resolve any discrepancies; (4) respond to requests for guidance and interpretations of the Lobbying Law; (5) conduct random audits; and (6) investigate unreported lobbying.

The Lobbying Bureau will not only continue the mandatory training program, but also expand the program by creating additional training videos. We will also expand our enforcement efforts to ensure that first time filers are trained within fifteen days of commencing lobbying activities. The Lobbying Bureau will continue to identify consistent trends of noncompliance and highlight those areas in our training materials and enforcement procedures.

In the upcoming year, the Lobbying Bureau expects to collaborate with the Department of Information Technology and Telecommunications ("DoITT"), and other city agencies, to develop and work towards implementing a new e-Lobbyist system. The modernization of e-Lobbyist will include numerous upgrades including: improving the user-friendliness of the system; text changes to screens and the user-guide; adding more drop-downs to replace free-form fields; improving the functionality of the automatic e-Lobbyist emails; and implementation of an enhancement which

will permit lobbyist/client filers, whose total compensation is between \$5,000 and \$10,000, to file 2 periodic reports per year instead of 6.

The Lobbying Bureau, in conjunction with DoITT, will continue to make information available via NYC Lobbyist Search, the public database of filings. The enhanced lobbyist search has enabled the Lobbying Bureau to further its mission of increasing transparency in government and allowed requests for information to be fulfilled more efficiently.

Analysis of Lobbying Data7

Each year the Lobbying Bureau analyzes the available data and reports on various macro and micro trends in City lobbying. In addition, the Lobbying Bureau receives many requests for information about City lobbying activity from the media and government watchdog organizations. In order to facilitate the transparency goals of the Lobbying Law, and in response to requests for information, lobbying data comparisons and analyses are included in the subsequent pages of this report. The data includes: top ten list of lobbyists based on compensation (see pages 12-18); top lobbyists ranked by number of clients (see pages 19-21); and top lobbyists ranked by number of employees (see page 30).

The analyses of lobbyist/client filers includes top ten lobbyist/client filers ranked by compensation (see pages 22-25) and top lobbyist/client filers ranked by number of employees (see page 31). The analyses also contain information regarding clients including: top clients ranked by total compensation paid to all retained lobbying firms (see pages 26-27); top clients ranked by number of lobbying firms retained (see page 28); the top ten lobbying contracts (see page 29); and a breakdown of registered clients' industries (see pages 32-33). Also included are the top activities by subject category (see pages 34-35), top targets (see page 36) and an analysis of the data reported in the fundraising reports (see page 37).







COMPARISON OF COMPENSATION OF TOP LOBBYISTS FROM 2018-2021*







COMPARISON OF TOTAL CLIENTS OF TOP LOBBYISTS FROM 2018-2021*







TOP TEN LOBBYIST/CLIENT FILERS OF 2021 BY COMPENSATION







DISTRIBUTION OF CLIENTS' INDUSTRIES IN 2021*





DISTRIBUTION OF SUBJECT CATEGORIES OF 2021*








ANALYSIS OF FUNDRAISING REPORTS 2021



ANALYSIS OF LOBBYING BUREAU STAFF TIME BY SUBJECT CATEGORY




DISTRIBUTION OF TELEPHONE INQUIRIES BY SUBJECT CATEGORY




DISTRIBUTION OF EMAIL INQUIRIES BY SUBJECT CATEGORY
