#### Introduction

This is the eleventh annual report issued by the Lobbying Bureau (the "Lobbying Bureau") of the Office of the City Clerk (the "City Clerk") pursuant to §3-212(c) of the Administrative Code of the City of New York (the "Administrative Code"), the text of which follows:

The city clerk shall prepare and post on the internet an annual report relating to the administration and enforcement of the provisions of this subchapter. Such report shall contain information regarding (i) the number of complaints received from the public and the disposition of such complaints; (ii) the number and amount of civil penalties imposed pursuant to subdivisions (a), (b), (c) and (d) of section 3-223 of this subchapter; (iii) the number and duration of orders issued pursuant to subdivision (a) of section 3-223 of this subchapter; (iv) the number of random audits conducted by the city clerk and outcomes thereof; (v) compliance programs developed and implemented for lobbyists and clients; (vi) the types and number of requests for assistance related to the lobbying law received by the city clerk, and, as soon as practicable, the average response and resolution times of such requests; (vii) the number of lobbyists filing statements of registration pursuant to section 3-213 of this subchapter for the first time; (viii) the subject matter of lobbying activity most frequently reported by lobbyists; (ix) the lobbying targets most frequently reported by lobbyists; (x) the lobbyists that received the highest compensation; and (xi) such other information and analysis as the city clerk deems appropriate. Such report shall be posted on the internet no later than March first of each year and shall contain information relating to the preceding calendar year.

Listed below is the information required by the above listed section of New York City's lobbying law ("Lobbying Law") for calendar year 2016.

#### (i) Number of complaints received from the public and the disposition of such complaints.

In 2016, the Lobbying Bureau received two complaints from the public regarding possible violations of the Lobbying Law; one of which was resolved and the other remains under investigation. In addition, an open complaint from a prior year was closed. The results of the Lobbying Bureau's closed complaints are as follows:

- 1. A complaint was made that GFI Development Company, LLC ("GFI") violated Administrative Code §§3-213(a)(1), 3-216(a)(1), and 3-217(a) *et seq*. GFI applied for and was granted amnesty in 2016. As a result, the investigation was closed.
- 2. A complaint was made that Phipps Houses ("Phipps") and Sunnyside-Barnett Associates LLC ("Sunnyside-Barnett") violated Administrative Code §§3-213(a)(1), 3-216(a)(1), and 3-217(a) *et seq*. Phipps applied for and was granted amnesty in 2016. As a result, the investigation against Phipps was closed. The Lobbying Bureau also determined that there was no probable cause that Sunnyside-Barnett violated the Lobbying Law.

## (ii) Number and amount of civil penalties imposed pursuant to subdivisions (a), (b), (c) and

#### (d) of §3-223 of the Administrative Code.

Violators of the Lobbying Law are subject to the penalties detailed in Administrative Code §3-223 *et seq.* Pursuant to Administrative Code §3-223(a), the penalties for knowing and willful violations of the Lobbying Law include: a civil penalty not to exceed \$30,000; the issuance of a cease and desist order; or both a civil penalty and a cease and desist order. Pursuant to Administrative Code §3-223(b), violators are subject to a civil penalty not to exceed \$30,000 for violating a cease and desist order or for violating the proscription against contingency agreements. In addition to penalties for any late filing, pursuant to Administrative Code §3-223(c), violators may be subject to a civil penalty, not to exceed \$20,000, if a violation is not cured. Lastly, for any violation of the Lobbying Law not covered in the foregoing provisions, pursuant to Administrative Code §3-223(d), violators may be subject to a civil penalty not to exceed \$20,000, if a violation is not cured.

Listed below are late filing penalties<sup>1</sup> incurred for each reporting period as of February 28, 2017.

The late filing penalties contained in this report are restricted to penalties resulting from the late filing of 2015 annual reports (client annual reports and sixth periodic reports) and 2016 filings including: statements of

registration, amended statements of registration, first through fifth periodic reports, and first through fifth periodic fundraising and political consulting reports.

#### 2015 Annual Reports (Client Annual Reports and Sixth Periodic Reports)

The Lobbying Bureau identified 17 Lobbyists<sup>2</sup> that failed to timely file an aggregate of 30 annual reports<sup>3</sup> for 2015. For this failure, such Lobbyists incurred \$4,525 in aggregate late filing penalties. (See <u>Appendix A</u> attached hereto.)

The Lobbying Bureau identified 199 late client annual reports. For this failure, such clients incurred \$119,255 in aggregate late filing penalties. (See Appendix B attached hereto.)

No civil penalties were warranted for the late filing of annual reports.

#### 2016 Statements of Registration and Periodic Reports

The Lobbying Bureau identified 51 Lobbyists who failed to timely file an aggregate of 82 statements of registration. For this failure, such Lobbyists incurred \$63,475 in aggregate late filing penalties. (See <u>Appendix C</u> attached hereto.)

The Lobbying Bureau identified 12 Lobbyists who failed to timely file an aggregate of 15 amended statements of registration. For this failure, such Lobbyists incurred \$14,425 in aggregate late filing penalties. (See <u>Appendix D</u> attached hereto.)

The Lobbying Bureau identified 12 Lobbyists who failed to timely file an aggregate of 21 first periodic reports. For this failure, such Lobbyists incurred \$14,555 in aggregate late filing penalties. (See <u>Appendix E</u> attached hereto.)

The Lobbying Bureau identified 19 Lobbyists who failed to timely file an aggregate of 30 second periodic reports. For this failure, such Lobbyists incurred \$9,685 in aggregate late filing penalties. (See <u>Appendix F</u> attached hereto.)

The Lobbying Bureau identified 21 Lobbyists who failed to timely file an aggregate of 26 third periodic reports. For this failure, such Lobbyists incurred \$8,835 in aggregate late filing penalties. (See <u>Appendix G</u> attached hereto.)

The Lobbying Bureau identified 26 Lobbyists who failed to timely file an aggregate of 29 fourth periodic reports. For this failure, such Lobbyists incurred \$11,390 in aggregate late filing penalties. (See <u>Appendix H</u> attached hereto.)

The Lobbying Bureau identified 19 Lobbyists who failed to timely file an aggregate of 23 fifth periodic reports. For this failure, such Lobbyists incurred \$5,295 in aggregate late filing penalties. (See <u>Appendix I</u> attached hereto.)

No civil penalties were warranted for the late filings detailed in the preceding paragraphs.

#### 2016 Fundraising and Political Consulting Reports

In total, the Lobbying Bureau identified 10 Lobbyists who failed to timely file a total of 10 fundraising and political consulting reports. For this failure, such Lobbyists incurred \$29,550 in aggregate late filing penalties. (See <u>Appendix J</u> attached hereto.)

No civil penalties were warranted for the late filing of fundraising and political consulting reports.

#### 2016 Late Termination Notices

In total, five clients incurred an aggregate of \$7,700 in civil penalties for failing to timely cure late termination notices. (See Appendix K attached hereto.)

#### 2016 Incorrect Reports

In total, three Lobbyists incurred an aggregate of \$6,300 in civil penalties for failing to timely cure seven incorrect reports. (See <u>Appendix L</u> attached hereto.)

## (iii) Number and duration of orders issued pursuant to subdivision (a) of §3-223 of the Administrative Code.

None.

#### (iv) Number of random audits conducted by the city clerk and outcomes thereof.

The Lobbying Bureau audited 43 Lobbyists in 2016. The audits encompassed an examination of all filings made in 2015 by the randomly selected Lobbyists to determine if such filings were complete, accurate, timely filed and otherwise in compliance with the Lobbying Law. The audits resulted in the issuance of approximately 106 findings and 106 required

actions. Samples of audit findings included: reporting incorrect compensation and expenses; failing to file a termination notice; reporting incorrect compensation; failing to file timely reports; failing to properly describe subject details; missing target information; registering a client in the wrong name; and failing to list lobbying employees. Examples of required actions included: amending reports; providing an affidavit to corroborate financial information; and filing a termination notice.

#### (v) Compliance programs developed and implemented for lobbyists and clients.

The Lobbying Bureau works with filers<sup>4</sup> to improve compliance with the Lobbying Law in a variety of ways including training, outreach and other educational efforts. In addition, the Lobbying Bureau receives numerous telephone and e-mail inquiries throughout the year for: assistance with filing reports; questions regarding requirements of the Lobbying Law; and technical assistance with e-Lobbyist. See (vi) The types and number of requests for assistance related to the lobbying law received by the city clerk for further information. Responding to these questions and requests for assistance continues to be an integral part of the Lobbying Bureau's daily functions.

#### **Training**

#### Mandatory Training

Local Law 129 of 2013 included a mandatory training requirement for Lobbyists. Pursuant to Administrative Code §3-219(h), Lobbyists that file a statement of registration must register for training within 15 days of the commencement of lobbying. Subsequently, Lobbyists must complete the training biennially. If a lobbyist registers 30 or more clients and lists five or more lobbying officers or employees, then two officers or employees, one of whom must have lobbied in the prior year, must complete the training.

The Lobbying Bureau started its mandatory training program in July 2016. It conducted 42 trainings from July through November 2016 with approximately 400 people attending. Each session included a detailed overview of the requirements of the Lobbying Law and provided in-

depth instructions on filing reports in e-Lobbyist. Each attorney who attended was eligible to receive 1.5 continuing legal education credits. In 2017, the Lobbying Bureau will continue the mandatory training program. Pursuant to the Lobbying Law, Lobbyists have two years to comply with the requirement.

#### **Other Training**

The Lobbying Bureau also held specialized training for the amnesty program. See the *Amnesty Program* for further information.

In the summer of 2016, the Lobbying Bureau created a <u>YouTube channel</u> to better assist filers in completing reports on e-Lobbyist. Five videos have been added to the channel on topics including: what is lobbying; how to create an e-Lobbyist account; how to enroll in e-Lobbyist; the difference between a principal officer and a designee; and the employee store. Each video contains an overview as well as step-by-step filing instructions. The Lobbying Bureau will add videos to the channel in 2017.

#### **Outreach Efforts**

## <u>Notification to Recipients of Discretionary Funds under the City Council Fiscal Year</u> 2017 Adopted Expense Budget - Schedule C

The Lobbying Bureau sent letters to entities that received discretionary funding from the City Council in fiscal year 2017. Over 1,800 letters were sent to organizations that were not registered lobbyists. Enclosed with the letter was a summary of the Lobbying Law. The letter alerted entities to the Lobbying Law and encouraged them to review their activities and related expenses to determine whether or not they were required to comply. The Lobbying Bureau received numerous telephone and email inquiries as a result of this outreach effort.

#### Comparison of New York City and New York State Lobbying Reports

The Lobbying Bureau continued its efforts to uncover unreported City lobbying in 2016 by comparing more than 7,000 statements of registration filed with the Joint Commission on Public Ethics ("JCOPE") with statements of registration filed with the Lobbying Bureau as of September 14, 2016.

It was determined that in total, 17 entities reported lobbying City targets with JCOPE but did not file a statement of registration with the Lobbying Bureau. As a result, the Lobbying Bureau sent letters to the entities. It was determined that 16 of these entities were not required to file statements of registration for various reasons including: (1) the entity inadvertently listed a City target on the JCOPE statement of registration when no City lobbying took place; (2) the entity did not exceed the \$5,000 reporting threshold for City lobbying; or (3) the entity filed a statement of registration with the Lobbying Bureau under a different legal entity name. The entities that were not required to file statements of registration with the Lobbying Bureau submitted supporting documentation to justify this determination. One entity was required to file a 2016 statement of registration. The entity complied and paid a late filing penalty.

#### Other Compliance Efforts

The Lobbying Bureau routinely examines reports filed on e-Lobbyist to determine the accuracy of the information contained in the statement of registration, retainer agreements and periodic reports. Among the areas of review are: start and end dates of lobbying activities; entity names; and compensation.

#### Date Issues

In 2016, the Lobbying Bureau discovered approximately 157 issues with start and end dates in Lobbyists' filings by comparing the dates on the statements of registration with the dates listed on the retainer agreements. Lobbyists were notified of any discrepancies and instructed to resolve the discrepancy by amending either the date on the statement of registration or the date on the corresponding retainer agreement.

#### Name Issues

In order to resolve name discrepancies, the Lobbying Bureau cross-checked client names listed on the statements of registration with the corresponding retainer agreements contained in e-Lobbyist. The Lobbying Bureau discovered approximately 202 issues involving entity names. The Lobbying Bureau instructed the entities to correct their name by: (1) requesting a change of the enrollment name; (2) filing an amended statement of registration with an amended retainer

agreement listing the correct name; or (3) requiring both a name change and submission of an amended retainer.

#### Compensation Discrepancies

In order to resolve compensation discrepancies, the Lobbying Bureau cross-checked the compensation listed in the periodic reports with the compensation listed in the corresponding retainer agreements. The Lobbying Bureau discovered over 133 instances where the compensation amount listed in a periodic report did not match the compensation listed in the retainer agreement. The Lobbyists were notified of the discrepancy and instructed to resolve it by either amending the compensation reported or by providing a letter justifying the discrepancy.

## (vi) The types and number of requests for assistance related to the lobbying law received by the city clerk.

In 2016, the Lobbying Bureau recorded its activities and the types and number of requests received.<sup>5</sup> From January 1, 2016 through December 31, 2016, the Lobbying Bureau's time was allocated as follows: compliance 37%, audits 18%, outreach and education 14%, enforcement 13%, e-Lobbyist assistance 10%, administration 6%, and investigations 2% (see page 42). In addition, the Lobbying Bureau received approximately 3,478 telephone calls (see pages 43-45) and 6,280 email requests (see pages 46-48). The majority of telephone calls involved filers requesting technical assistance with completing a filing on e-Lobbyist. The majority of emails involved filers requesting clarification on how to report lobbying activities. There was an 84% increase in the number of telephone calls received in 2016 (see page 45) and a 28% increase in the number of emails received by the Lobbying Bureau in 2016 compared to 2015 (see page 48). A number of factors may have contributed to this increase including the Lobbying Bureau's increased outreach and education efforts related to the amnesty program. The outreach efforts generated significant inquiries regarding the Lobbying Law and how to complete filings.

## (vii) The number of lobbyists filing statements of registration pursuant to §3-213 of the Administrative Code for the first time.

In 2016, about 102 Lobbyists filed statements of registration for the first time. This is a 31% increase from last year. This is likely attributable to the Lobbying Bureau's amnesty program and its education and outreach efforts. Thirty-three of these entities are lobbyists and 69 entities are lobbyist/client filers. The 69 lobbyist/client filers' industries were reported as follows: 24 not-for-profit organizations and/or community service organizations; 21 financial service companies; and the remaining as unions, law firms, real estate, construction, healthcare and education companies.

## (viii) The subject matter of lobbying activity most frequently reported by lobbyists and lobbyist/client filers.

#### (xi) Other information and analysis.

#### 2016 Amendments to Chapter 1 of Title 51 of the Rules of the City of New York

In 2016, the Lobbying Bureau amended its rules to allow a person other than the principal officer to certify reports in e-Lobbyist. The amended rule also provided that the City Clerk could accept amnesty applications by email and mail so long as the applications were postmarked by the last day of the amnesty period. The proposed amended rule was published in the City Record

on October 17, 2016. The public hearing was held on November 17, 2016. The amended rule was published in the City Record on November 25, 2016 and took effect on February 1, 2017.

#### Advisory Opinion

In response to a written request inquiring whether an applicant or his or her representative is engaged in lobbying when such applicant applies for work permits from the Department of Buildings ("DOB"), the City Clerk opined that an application to DOB relating to the issuance of work permits, approvals or other construction-related documents and determinations by DOB is not lobbying because the activity is not included in the definition of lobbying. *See* Advisory Opinion 2016-1 available at: http://www.cityclerk.nyc.gov/html/lobbying/2016-1.shtml.

#### Announcement

In 2016, the Lobbying Bureau sent an announcement to lobbyists regarding the changes to the required terms of retainer agreements as set forth in the 2015 amendment to chapter 1 of title 51 of the Rules of the City of New York. The announcement provided a guide to these changes and included a sample retainer agreement. The announcement was initially sent in August and again in December.

#### The Amnesty Program

Local Law 129 of 2013 created an amnesty program to increase compliance with the Lobbying Law. Pursuant to the Administrative Code, any filer that was required to file, but never filed a statement of registration or a client annual report on or after December 10, 2006 was eligible to apply for amnesty and was required to immediately comply with the Lobbying Law. If amnesty was granted, then late fines and civil penalties were waived.

The amnesty period commenced on January 1, 2016 and continued through June 30, 2016. The Lobbying Bureau received 127 applications for amnesty over the six-month period. In total, 120 entities were granted amnesty, six entities were denied and one entity was granted amnesty as a lobbyist but denied as a client.

In order to maximize amnesty participation, the Lobbying Bureau engaged in various training and outreach efforts in 2016. Efforts included: holding training sessions, publishing

announcements and advertisements, distributing brochures, the deployment of social media and presenting at community boards and other public meetings throughout the five boroughs.

#### **Training**

The Lobbying Bureau held weekly amnesty training sessions prior to and during the amnesty period. The training focused on specific questions about the amnesty program and the application process.

On January 19, 2016, the Lobbying Bureau attended and presented at the "Nonprofit Advocacy 101: Putting your Organization on the Radar of Elected Officials" workshop. The Lobbying Bureau's presentation included an overview of the Lobbying Law and the amnesty program and a question and answer period. Attendees included representatives from over 20 not-for-profit organizations.

On April 14, 2016, the Lobbying Bureau participated in the "Lobbying Laws and Regulations" CLE program given at New York Law School. The Lobbying Bureau's presentation included an overview of the Lobbying Law and the amnesty program and a question and answer period.

On June 9, 2016, the Lobbying Bureau held an information session for architects and engineers at the Office of Administrative Trials and Hearings. The session focused on the Lobbying Law's application to architects and engineers, addressed various concerns raised by the architect and engineer community and provided information about the amnesty program. As a result of this information session and various other outreach efforts, many architects and engineers applied for amnesty.

On June 21, 2016, the Lobbying Bureau presented at the "Civic Engagement & Lobbying for Nonprofits" workshop sponsored by the Mayor's Office of Contract Services ("MOCS"). The Lobbying Bureau's presentation included an overview of the Lobbying Law and the amnesty program and a question and answer period. Attendees included representatives from not-for-profit organizations.

#### Outreach

In the spring of 2016, to publicize the amnesty, the Lobbying Bureau sent approximately 97,000 emails to various vendors that were listed in the MOCS databases including: VENDEX, PIP and FMS. The Lobbying Bureau received numerous inquiries about the emails.

In the winter of 2016, the Lobbying Bureau placed advertisements in the following publications: (1) City & State (print version for January and April and online edition); (2) The Chief (online edition); (3) Pensions & Investments (online edition); and (4) Staten Island Live (online edition).

#### Social Media

In 2016, the Lobbying Bureau continued and expanded its social media presence by continuing to utilize its twitter account <u>@NYCLobbying</u> and by creating a <u>YouTube channel</u>.

#### Public Meetings

In addition to attending each borough board meeting in 2015, in 2016 the Lobbying Bureau made amnesty presentations at 35 different community board meetings throughout the five boroughs. The Lobbying Bureau also conducted in person outreach and made telephone calls to various stakeholders throughout the City during the amnesty period.

#### Number of Reporting Lobbyists and Clients

As of February 28, 2017, approximately 1,953 Lobbyists and 4,224 clients were enrolled in e-Lobbyist. In 2016, approximately 2,639 statements of registration were filed on e-Lobbyist and Lobbyists paid approximately \$190,000 in registration fees.

#### Outlook For 2017

In 2017, the Lobbying Bureau will enhance lobbyist search, the public database of filings. The enhancement will allow users to search for filings by lobbyist, client, target, subject, compensation and year. In addition, a PDF version of each filing will be available on the database.

In addition, the Lobbying Bureau will continue to improve the e-Lobbyist filing system and enhance the user-friendliness of the system including: text changes to screens and the user-

guide; adding more drop-downs to replace free-form fields; editing the automatic e-Lobbyist emails; adding the ability to upload a PDF to each filing; and continuing to work on an enhancement which will permit lobbyist/client filers, whose total compensation is between \$5,000 and \$10,000, to file two periodic reports per year instead of six.

In addition, to ensure the integrity of the database, the Lobbying Bureau will remain focused on confirming the veracity of the reports filed by Lobbyists and clients. The Lobbying Bureau will continue to check information contained in the statements of registration and periodic reports to verify the accuracy of the filings and work with all filers to resolve any discrepancies. The Lobbying Bureau will continue to send announcements to notify filers of changes to e-Lobbyist, changes in procedure, and any consistent trends of noncompliance.

Local Law 129 of 2013 included certain exclusions from the definition of lobbying applicable to architects and engineers. It stated that the City Clerk promulgate rules to further clarify the exclusions. In 2017, the Lobbying Bureau intends to promulgate such rules.

Furthermore, the Lobbying Bureau will continue to fulfill its statutory duties including conducting random audits and investigating unreported lobbying.

#### Analysis of Lobbying Data<sup>6</sup>

Each year the Lobbying Bureau analyzes the available data and reports on various macro and micro trends in City lobbying. In addition, the Lobbying Bureau receives many requests for information about City lobbying activity from the media and government watchdog organizations. In order to facilitate the transparency goals of the Lobbying Law, and in response to requests for information, lobbying data comparisons and analyses are included in the subsequent pages of this report. The data includes: top ten list of lobbyists based on compensation (see pages 15-21); top lobbyists ranked by number of clients (see pages 22-24); and top lobbyists ranked by number of employees (see page 33).

The analyses of lobbyist/client filers includes top ten lobbyist/client filers ranked by compensation (see pages 25-27) and top lobbyist/client filers ranked by number of employees (see page 34). The analyses also contains information regarding clients including: top clients ranked by total compensation paid to all retained lobbying firms (see pages 29-30); top clients











## COMPARISON OF TELEPHONE CALLS BY SUBJECT CATEGORY FROM 2014-2016\*




